EXECUTIVE ORDER

BY THE GOVERNOR:

The Georgia Department of Community Affairs has been charged with the responsibility for administering the affairs of the Georgia Housing and Finance Authority including the administration of tax credit allocations; and

The Georgia Department of Community Affairs, acting on behalf of the Georgia Housing and Finance Authority, published a draft 2004 Qualified Allocation Plan on the Departments' website on November 1, 2003, and gave due and public notice of the availability of the 2004 Draft Qualified Allocation Plan and of the hearings which were open to the public on the Draft Qualified Allocation Plan by running advertisements on Sunday, November 3, 2003, and Sunday, November 10, 2003, in the Albany Herald, The Atlanta Journal-Constitution, the Americus Time Recorder, the Augusta Chronicle, the Columbus Telegraph, the Macon Telegraph, the Savannah News Press, and the Dublin Courier Herald; and

The Georgia Department of Community Affairs held hearings open to the public pursuant to due and reasonable notice in Columbus, Georgia on November 18, 2003, at 10:00 a.m., in Dublin, Georgia on November 17, 2003, at 10:00 a.m., and in Atlanta, Georgia on November 21, 2003, at 10:00 a.m.; and

Following the hearings and public comment period, the Board of Directors adopted the Qualified Allocation Plan on December 3, 2003, for the Georgia Housing and Finance Authority in the form attached hereto as Exhibit A.

It is hereby ordered that, solely for the purpose of satisfying the requirements for such approval under Section 42(m)(1) of the Internal Revenue Code as amended by the Omnibus Budget Reconciliation Act of 1989, the Qualified Allocation Plan in the form approved by the Board of Directors for the Georgia Housing and Finance Authority on December 3, 2003, in the form attached hereto as Exhibit A is approved.

Exhibit A

Points for Previous Projects within a Local Government

Six (6) points will be added if the proposed development site is within the boundaries of a Local Government in which a 9% Credit, 4% Credit, and/or HOME project has not been awarded within the last three (3) DCA funding cycles, OR four (4) points will be added if the proposed development site is within the boundaries of a Local Government in which a 9% Credit, 4% Credit, and/or HOME project has not been awarded in the last two (2) DCA funding cycles. For example, if no projects were awarded in unincorporated Cobb County for the last three DCA funding cycles, but one was awarded in the City of Marietta in 2001, an Application for a project from an unincorporated area of Cobb County would receive six (6) points.

For Scattered Site Projects, as defined in Section 11B(1)(a) and (b) of the Plan, each non-contiguous multifamily project or non-contiguous parcel may be considered for points in this category. However, the Application will be awarded a maximum of six (6) points in this category.

To determine the points available in this category for any given 2004 Applicant, refer to the attached list of projects that have been sorted by county. The first two digits of the project number reflect the year of the DCA award.

- 6 Points 2004 Application is within a Local Government (city or unincorporated portion of a county) that is not on the attached list for 2001, 2002, and 2003.
- 4 Points 2004 Application is within a Local Government (city or unincorporated portion of a county) that is not on the attached list for 2002 or 2003.
