

# THE STATE OF GEORGIA

## **EXECUTIVE ORDER**

## BY THE GOVERNOR:

WHEREAS: The 2002 Georgia General Assembly passed House Bill 885, which created the State Council for Interstate Adult Offender Supervision, and which bill was signed into law on May 16, 2002, as Act 964, codified as O.C.G.A. § 42-9-80 et seq; and

WHEREAS: Pursuant to O.C.G.A. § 42-9-82 (1), the Governor shall by executive order establish the initial composition terms and compensation of the State Council for Interstate Adult Offender Supervision, and the qualifications, term and compensation of the Compact Administrator.

NOW THEREFORE, PURSUANT TO THE AUTHORITY VESTED IN ME AS GOVERNOR FO THE STATE FO GEORGIA, IT IS HEREBY

ORDERED: That the State Council for Interstate Adult Offender Supervision shall be composed of the following:

One representative from the executive branch of government, to be appointed by the Governor and to serve at his pleasure,

The Commissioner of Corrections, or his designee,

The Chairman of the State Board of Pardons and Paroles, or his designee,

One representative from the legislative branch of government, to be appointed jointly by the Speaker of the House of Representatives and the President of the Senate and to serve at their pleasure,

One representative from the judicial branch of government, to be appointed by the Chief Justice of the Supreme Court and to serve at his pleasure, One representative of a victims group to be appointed by the Governor and to serve at his pleasure, and

The Compact Administrator, who shall be elected by majority vote of the members of the State Council for Interstate Adult Offender Supervision and shall serve at the pleasure of the council. As each Compact Administrator leaves office, the council shall elect a new Compact Administrator to a term of three years;

### IT IS FURTHER

ORDERED: That the State Council of Interstate Adult Offender Supervisions shall meet at least two times per year. The members shall receive no compensation for their service. Non-state employed members are eligible for reimbursement of travel expenses, in accordance with state travel guidelines for the Department of Corrections and the State Board of Pardons and Paroles.

### IT IS FURTHER

ORDERED: That the Compact Administrator shall act as Georgia's representative to the Interstate Commission for Adult Offender Supervision and shall be responsible for the administration and management of Georgia's supervision and transfer of offenders subject to the terms of the compact, compliance with rules adopted by the Interstate Commission and policies adopted by the State Council for Interstate Adult Offender Supervision. In order to be considered for election as the Compact Administrator, candidates must be employed with the Georgia Department of Corrections or the Georgia State Board of Pardons and Paroles. The Compact Administrator shall receive no additional compensation for his services as the Compact Administrator of the State Council for Interstate Adult Offenders Supervision, but shall be entitled to reimbursement by the State for travel expenses in accordance with state travel regulations. The Department of Corrections and the State Board of Pardons and Paroles shall be jointly responsible for reimbursement of travel expenses.
