EXECUTIVE ORDER

BY THE GOVERNOR:

CORRECTION TO THE EXECUTIVE ORDER ISSUED NOVEMBER 6, 1998

WHEREAS: High Falls Park, located in Monroe county, is owned by the State of Georgia and

under the custody of the Department of Natural Resources; and

WHEREAS: The State purchased the real property that comprises High Falls State Park to

protect its significant natural, recreational and cultural resources, and to allow compatible forms of scientific research, public education, and recreation; and

WHEREAS: The General Assembly recognizes the above needs and the public interest in the

state's heritage and, therefore, has enacted the Heritage Trust Act of 1975

(Georgia Laws 1975, p. 962); and

WHEREAS: Said Heritage Trust Act of 1975 provides that any real property owned by the

State of Georgia and under the custody of the Department of Natural Resources may be dedicated as a Heritage Preserve after written recommendation by the

Board of Natural Resources and approval by the Governor; and

WHEREAS: Upon the written recommendation of the Board of Natural Resources, the

Honorable Zell Miller, Governor of the State of Georgia, designated the High Falls State Park as a Heritage Preserve by Executive Order dated November 6, 1998, which was filed and recorded in the Office of the Clerk of Superior Court of Monroe County on December 22, 1998 at Vol. 596, pages 130-137 and filed and recorded with the State Properties Commission on March 5, 1999, at Misc.

Proclamation Book VI, page 290; and

WHEREAS: The November 6, 1998 Executive Order mistakenly referenced two (2) acres in

Monroe County adjacent to High Falls Lake that should not have been included

in the Heritage Preserve dedication; and

WHEREAS: The Board of Natural Resources has made a written recommendation that the

November 6, 1998 Executive Order dedicating the High Falls State Park as a Heritage Preserve be corrected, and I, as Governor, concur in the Board's desire

to correct the error.

NOW, THEREFORE, PURSUANT TO THE AUTHORITY VESTED IN ME AS GOVERNOR OF THE STATE OF GEORGIA, IT IS HEREBY

ORDERED:

That the November 6, 1998 Executive Order is corrected to remove the reference to the two (2) acres erroneously included therein.

IT IS FURTHER

That the Exhibits "A" and "B" to the November 6, 1998 Executive Order are **ORDERED:**

deleted in their entirety and the attached Exhibits "A" and "B," which are incorporated herein by this reference, shall supersede and replace the November

6, 1998 Executive Order Exhibits "A" and "B," respectively.


That this Executive Order be filed in the Office of the Clerk of the Superior Court **ORDERED:**
